Sec. 2. As used in this act, "task force" or "DEPORT task force" means the developing effective policies on orderly removal and transportation (DEPORT) task force created in section 3.

Sec. 3. (1) Subject to section 5, the developing effective policies on orderly removal and transportation (DEPORT) task force is created.

 - (4) If a vacancy occurs on the task force, the speaker of the house of representatives shall appoint an individual to fill the vacancy for the balance of the term. An appointment under this subsection must occur not more than 7 days after a vacancy begins.
 - (5) The speaker of the house of representatives may remove a member of the task force for any reason.
